

# PATROL AND INVESTIGATIVE INTERVIEW AND INTERROGATION TACTICS

Often viewed as a skill used mainly by an Investigator at the station, the ability to effectively interview and interrogate in the field is a talent needed by all Law Enforcement personnel. Whether involved in a detention for a field interview, or while on-scene questioning the witness or victim of a crime, or interrogating a perpetrator; the need for focused and effective questioning is obvious. When combined with a clear report for explaining whether a crime has occurred and how it should be handled, the ability to communicate and inquire can be critical for effective Law Enforcement.

This training has been designed to supply the basic skills necessary to communicate and question effectively in the field or at the station. Its focus is developing the ability to apply effective interview and interrogation procedures to aid Investigators and support an on-scene investigation of a crime or a citizen's call for service.

## TOPICS INCLUDE:

- How the interview and interrogation process differs and how each can be used to support investigations through the use of on-scene questioning for a wide-variety of patrol related functions.
  - An examination of the communication process and its use when interviewing and interrogating.
- Interview and interrogation tactics and techniques for use during Field Interrogation and while engaged in on-scene questioning.
- Body language indicators of deception, redirection and aggression. And how being aware of them can support investigations and officer safety.
  - A review of questioning strategies for some common Police-Citizen encounters (Domestic Violence, Stop and Frisk, Suspicious Person, etc.).
  - And more

*The instructor has taught communication and interview and interrogation techniques to support specific patrol and investigative functions at the basic and advanced academy levels. His personal experience in the application of those skills in the field, as a patrol officer, investigator and as a supervising task force agent will be used to focus and enhance this training.*
